Dear Trail User,

Thank you for your interest in the Palouse to Cascades State Park Trail.

Palouse to Cascades State Park Trail is a day-use only, non-motorized trail. Camping is not permitted. For approved day-use activities (walk, bike, equestrian) with groups of less than 20 people, the trail may be used after registration (no fee).

For groups larger than 20 people, or groups seeking to conduct activity outside of the normal daily recreation, a Special Activity Permit and permit fee is required. Please request this permit or use the one online <https://parks.state.wa.us/217/Special-Activities-Permit>. Special Activity Permits must be submitted 30+ days in advance or they will not be considered.

Palouse to Cascades State Park Trail (East) Distances

Beverly.....	Royal City Jct.....	16 miles
Royal City Jct.....	Warden	37 miles
Warden.....	Lind.....	21 miles
Lind.....	Ralston	18 miles
Ralston.....	Marengo	19 miles (Detour via Kline Road)
Marengo.....	Benge-Ritzville Rd Xing	5 miles
Benge-Ritzville Rd Xing.....	Revere	10 miles
Revere.....	Ewan	15 miles (Detour via Cayuse Lake Rd.)
Ewan.....	Kenova.....	15 miles (Detour via Stephen Rd.)

The Rock Lake area has both East and West side in-and-out experiences. Heading West to East, you can proceed 3 miles in before encountering an impassable trestle. Heading East to West, you can safely proceed 2.25 miles in before encountering a restricted tunnel.

Rules of Conduct

Motorized vehicles, including snowmobiles, are prohibited on the corridor at all times, except for authorized administrative or health and safety purposes. The Lind to the Idaho Border corridor is open for non-motorized use, by registration only. Washington State Parks may close portions of the corridor to reduce fire danger, to protect public safety, or perform maintenance. If you are requesting a grazing or agricultural permit/lease, please contact 509-337-6457 for more information.

Registrations

- The registration may be submitted via email or mail (see first page for details), or you may complete the online registration at <https://parks.state.wa.us/FormCenter/Parks-11/Palouse-to-Cascades-State-Park-Trail-use-74>. You will receive a code to open the locked gates along the Trail once you have submitted a registration.

Requirements for Use

Sanitation

Trail users **WILL NOT**

- Leave or scatter trash or refuse.
- Leave human waste within ¼ mile of buildings, water sources, lakes, ponds, or streams (running or dry). Waste must be buried. Special Activity Permit conditions for groups will require removal of human waste.

Public Behavior

Trail users **WILL NOT**

- Destroy, alter, or damage buildings, signs, equipment, markers, other structures or property.
- Erect unauthorized shelters, enter structures without permission, or camp on the Trail.
- Destroy, deface or remove any natural feature, vegetation or surface.
- Hunt or discharge firearms. No weapons can be legally discharged on the Trail. Washington State Parks does not allow hunting on any State Parks property.
- Possess or ignite fireworks.
- BUILD ANY FIRES.
- Allow animals to be unleashed or out of control (leash cannot be longer than eight feet long).

Penalties

If there are any violations of state law or the terms or conditions of the registration, Washington State Parks will revoke the registration and the registerer will be subject to penalties.
