

Capital budget summary

2021-23 New bond capacity for projects:

House: \$49.4

Senate: \$78.4 Difference \$29.1 million

WWRP between \$100 and \$110 million

Use of capital preservation pools

- House \$10 million
- Senate \$47 million



#### Law Enforcement Reform

Bills that passed the Legislature

ESHB 1054- Limits use of chokeholds, police dogs, tear gas, use of military weapons

ESHB 1267- Governor Request Establishes Office of Independent Investigations

ES2SHB 1310- Standards of force

E2SSB 5051- CJTC Training and decertification standards

SSB 5066- Police officer duty to intervene



Letter from Parks, RCO, and WRPA on including long-distance multi-modal trails






Policy and Budget Development

Preparation for next legislative session will begin in May.

2022 Legislative Session-Supplemental (60 Days)

Supplemental Budget development- emergent issues, emergencies

Agency request legislation- Commission to provide direction in July
